## FPC25/018 Neighbourhood Development Plan

The Clerk advised that the NDP was still with the neighbourhood planning team for the SEA & HRA Screening. The unspent funding had been returned. The NDP Steering group were now focusing on the consultation strategy for Regulation 14 consultation.

The Defibrillator at Higher Trewhiddle had been installed and Cllr Cleverdon would be arranging training for the residents. The Defibrillator was funded from The Community infrastructure levy (CIL) The clerk would update the Parish Councils web site and the local social media sites.

Cormac are awaiting approval from the Environment Agency for a vegetated wall to repairs to the areas of erosion along the riverbank, works had been scheduled to start in the autumn.

Cllr Dowrick reported that the drain cover next to the bump on the Pentewan Road just before Sunny corner is showing signs of a leak this could be related to the bump in the road. Ther clerk will report to Highways Again.

Cllr Strawford reported that the bins outside of the Ship In Pentewan are still causing concern as they protrude into the road . It was **RESOLVED** that The Clerk will write to the licensee.

Cllr Bonetta asked the Parish Council to support his request for the installation of a bus stop on Truro Road near to the new Higher Trewhiddle Development, Cllr Mustoe offered to take this up with Highways.

Cllr Avery reported that the parking area in Pentewan Square had not been swept for long time and was covered in detritus. The clerk would contact highways to get this swept.
