#### (24/254) Declarations of Interest on Items on the Agenda

Cllrs Strawford declared an interest in agenda item 13d, Pentewan Car Park. Cllr Strawford had been granted a dispensation by the Parish Council to speak and vote on matters relating to the car park until May 2025.

## (24/255) Chairman's Announcements

The Chair thanked Cllr Bunney for all the help he had given the Parish Council and his calm common-sense approach to all matters and wished him well for the future. Cllr Bunney thanked the members of the Parish Council and said it was a pleasure working with the team on the various project especially Cllr Muskett for his contribution to the White River Project, a great example of good practice project for the community.

## (24/256) Public Participation

Rupert Warwick from the Watery Lane Nursery and two others attended to speak in relation to Planning application PA25/01079. They each gave a brief update on the project and answered Cllr questions related to the application. The project will help small startups and local businesses develop their activities in sustainable food production and low-impact materials. Through the smart use of water and energy, as well as green spaces, the site places biodiversity and natural resources at the forefront of sustainable development, while implementing strategies to reduce waste and CO2 emissions, helping Cornwall to reach Net Zero goals.

## (24/2581) Planning and Related Matters.

- (i) PA25/00646. Outline Planning Permission with some matters reserved (Access) for a proposed development of up to 77 extra care apartments (C3) and associated works. Pentreva Bungalow the Blantyre Centre Truro Road St Austell. PA25/01079. Development solar of photovoltaic (pv) array and battery storage units and associated infrastructure at Watering Lane Nursery Pentewan St Austell PL26 6BE. It was **RESOLVED** that the clerk would advise the planning department that Pentewan Valley Parish Council recognise the benefits of this unique project and support this application subject to the following conditions.
  - 1. A system to prevent debris and water being deposited on the Public highway at all times but especially during the construction and in line with the construction traffic management plan.
  - 2. Existing tree and hedges row are only reduced in size in line with the Ecological Impact assessment.
  - 3. Lighting on the site to be kept to a minimum and security fencing to be in keeping with the agricultural landscape.
  - 4. In the event that the businesses do not develop on site the solar array and storage is removed

The Parish Council also asks that the Planning department come back with any reserved matters relating to any of the above

(ii) PA25/01820. Proposal Application for Certificate of Lawful Development for an existing use namely continued use of dwelling as holiday use/unrestricted residential dwelling use. Location Mill House Polgreen Farm London Apprentice St Austell. This application was noted.
